

# TERMS OF THE “COMMUNITY IDEAS” TOOL

(referred to: “Tool”)

of June 29th, 2023

## **By submitting your Idea, You agree to the following:**

- The purpose of this project is to exchange general ideas and concepts ("Idea").
- You are the sole author of your Idea.
- Your Idea must not contain anything that is unlawful, tortious, fraudulent, deceptive, obscene, sexually explicit, defamatory, violent, threatening, harassing, abusive, falsely representative, or invasive of someone else's privacy. Your Idea must not include any content that infringes any third party intellectual property rights or otherwise violates third-party rights.
- In case your Idea constitutes a copyrighted work, You give Techland S.A. ("Company"), its licensors and affiliates, at the moment of your submission, a non-exclusive, worldwide, free-of-charge, transferrable, sublicensable, irrevocable license on all fields of exploitation known on the date on which such license is granted, including, without limitation the right to use, modify, reproduce, create derivative works from, distribute, transmit, communicate and publicly display/perform your Idea for commercial purposes or otherwise. Company will also have the right to authorize the exercise of derivative copyrights to such Idea and to exercise such rights. If, due to any reasons, under any provisions of applicable law, the license described here cannot be granted perpetually and irrevocably, after the initial period of 5 years you may terminate it with a 10 years notice period, while the rest of the terms described in this section remain unchanged.
- You understand that Company is under no obligation to use your Idea, select it for voting or use in any other present or future project.
- You are not entitled to receive, and hereby waive any right to, any compensation or other remuneration in connection with your Idea, including if and to the extent that Company chooses to exercise its rights. You hereby commit yourself not to exercise your moral rights to the Idea, especially against Company and in a manner that could violate or threaten the interests of Company.
- You are aware that a lot of ideas are generated in Company on an ongoing basis, and therefore You may not be the first person to have the Idea and even the same or similar ideas may be also generated in parallel, please keep this in mind.
